



**Legacy Health in collaboration with Oregon Health & Science University, Kaiser Permanente and Adventist Health** will open Unity Center for Behavioral Health in the fall of 2016. The Unity Center for Behavioral Health is expected to be a national model for providing compassionate mental health care in times of need. This unprecedented collaboration of four health systems shares the goal of providing care for all those in need through a combination of emergency, inpatient and robust transition to outpatient services and embraces the concepts of hope, recovery and resilience. The center will serve as a model setting to train a wide range of future healthcare providers.

The Unity Center will include 22 beds for adolescents, 79 adult patient beds, a Psychiatric Emergency Service (PES) and will also collocate navigators from organizations that provide community behavioral health services, helping to coordinate continued support to patients after discharge. The Psychiatric Emergency Service will be the only one of its kind in the Pacific Northwest.

A minimum of six years progressively more responsible experience within health care environment, including multi-hospital or integrated delivery system models with managed care. Previous business/administration experience required. Experience working in successful partnership with physicians. Experience working in leadership role with clinical specialty areas of Behavioral Health and Substance Use Disorder is desired. Experience in leading Social work departments with thorough understanding of Social issues related to inpatient and emergency behavioral health issues. Understanding of support areas of housekeeping, transportation and dietary services preferred. We are looking for strong leadership skills, knowledge of administrative and managerial systems and roles, knowledge of financial and operational systems, and experience with health care issues, demographics, financing, and policy changes.
