Mr. Conger,

As you know, we were scheduled to issue a final decision on the NEWCO application by Saturday, June 10. However, that decision is being extended to July 7. OHA needs more time, before issuing a final decision, to review your information submitted during the informal hearing process as well as additional information that very recently came to light, including the possible expansion of psychiatric beds at Cedar Hills Hospital, and the recent opening of Adventist Health's Emotional Wellness Center to provide outpatient behavioral health services.

It's important to note that the Certificate of Need rules require a thorough analysis of current and projected needs for health care services or facilities, and consideration of alternative, less-costly mechanisms for meeting care needs. OHA will make its final decision based on the most current data and information available.

We are putting together some additional links/information for you that you should have soon.
