Please take notice that an informal hearing will be held on March 17, 2017, at 9:00 a.m. in the Tilikum Conference Room at the Oregon Department of Justice Portland office, 100 SW Market St., Portland, Oregon 97201, regarding the proposed decision by the Oregon Health Authority (OHA) to deny NEWCO Oregon, Inc.'s application for a certificate of need for a 100-bed psychiatric hospital to be located at 9500 SW Day Road in Wilsonville, Oregon (CN #675). OAR 333-570-0070(5) through (9).

The informal hearing was requested by Ann Kasper, an affected party, and by NEWCO.

The informal hearing is for the purpose of providing an opportunity to the requesters to discuss the proposed decision with OHA. Other affected parties will be allowed to speak following the requestors' presentations. Participants (the applicant and affected parties) will each be allowed up to 20 minutes for a presentation. Representatives of OHA may question those testifying but no cross-examination of


persons or questioning of persons testifying is allowed. Participants appearing at the hearing need not be represented by counsel. The hearing is not subject to the Administrative Procedures Act and will not be conducted as a contested case hearing. Jana Fussell, Certificate of Need Coordinator for the Oregon Health Authority, will conduct the hearing.

Presenters and affected party may provide new information or suggest other actions that may result in OHA amending its proposed decision. If during the informal hearing process the applicant proposes to modify its application, the provisions of the OAR 333-570-0050(2) must be met. That is, OHA must agree to accept the amendment and OHA may condition the consideration of an amendment on the applicant granting an extension of the review period.

The applicant and affected parties must submit in writing new information that is presented orally at the informal hearing. OHA will allow the applicant and affected parties to submit information after the adjournment of the informal hearing, until March 27, 2017 at 5:00 p.m. Pacific Time, at which time the informal hearing is considered closed. OHA must receive the information by 5:00 p.m. Pacific Time on March 27, 2017, in order for the information to be considered by OHA in making its final decision.

OHA will issue a final decision by April 6, 2017. The final decision is subject to a reconsideration hearing if appealed within 60 days after the final decision is served. OAR 333-570-0070(10).
