AV was hospitalized approximately three weeks ago on a HH after he slammed his car going 80 MPH into a grain silo on purpose (he even unhooked his seat belt). He spent one to two weeks in a medical bed and then was transferred to Unity. He was transitioned to voluntary and spent approximately three weeks at Unity, when he was released with a plan. He at some point ended up back at Unity the same day he was released expressing passive suicidal thoughts of jumping off a bridge. He was reassessed for safety. He denied intent. He left the

hospital and at some point again the same day, jumped off a bridge into the water where he was rescued. He was hospitalized at OHSU with a plan to transfer back to Unity. [REDACTED] cell phone number is [REDACTED]
